Sound Engineering Agreement

This contract is for the services of Charles Street Entertainment on the engagement described below, made and entered into on _____ between the undersigned Purchaser of Services (herein after called "Purchaser") and Charles Street Entertainment (herein after called "CSE"). CSE is engaged severally on the terms and conditions on this contract. The purpose, terms and conditions are as follows:

Additional Terms and Conditions

This agreement of CSE to provide services is subject to proven detention by accidents, riot, strikes, epidemics, acts of God, or other legitimate conditions beyond their control. In any such event, any deposit will be immediately refunded to the Purchaser. All deposits are nonrefundable if cancelled within 10 days of the Event, unless the Event is cancelled by CSE.

The Purchaser and CSE agree that this contract is not subject to cancellation unless both parties have agreed to such cancellation. In the event the purchaser breaches the contract, he or she shall pay CSE the amount set forth above as "Wage agreed upon" as liquidated damages, of 10% interest thereon, plus a reasonable attorney's fee. It is hereby further agreed, that the Purchaser shall be held liable for any injury or damages to the sound engineer, or property of CSE, while on the premise of the said Event, if damage is caused by the Purchaser or Guests, members of his organization Event invitees, employees, or any other party in attendance, whether invited or not.

It is understood that if this is a "Rain or Shine" event, Charles Street Entertainment's compensation is in no way affected by inclement weather. For outdoor performances, the Purchaser will provide overhead shelter for setup area. CSE reserves the right, in good faith, to stop or cancel said performance should the weather pose a potential danger to himself, the equipment, or audience. Every effort will be made to continue the performance. However, safety is paramount in all decisions. CSE's compensation will not be affected by such cancellation.

Charles Street Entertainment requires three 20 amp 120 volt circuit outlets. These circuits must be free of all other connected loads. Any delay in the performance or damage to CSE's equipment due to improper power is the responsibility of the Purchaser.

By executing this contract as Purchaser, the person executing said contract, either individually, or as an agent or representative, represents and warrants that he or she is at least eighteen (18) years of age, and further, if executing said contract as agent or representative, that he or she has the authority to enter into this agreement and should he or she not have such authority, he or she personally accepts and assumes full responsibility and liability under the terms of this contract. This contract will supersede any other contract. If any part of this contract is illegal or unenforceable, the remaining provisions of this contract will remain valid and enforceable to both parties.

This contract contains the entire agreement between the parties and no statement, promises, or inducements made by any party hereto, or agent or representative or either party hereto, which are not contained in this written contact, shall be valid or binding. This contract shall not be enlarged, modified, or altered except by both parties and endorsed hereon.
